
- c) Click on the link in your email to verify your registered email address



- d) Once verified, you may login into your Fundaztic account. You may fill up your details under Personal Details and Contact Details tab.



- b) Click submit and Activation Email with Activation Code has been sent to your registered email.




c) Input the Activation Code on the Activation page and click Activate.



d) You may login into your Fundaztic account. You may fill up your details under Personal Details and Contact Details tab.






